#### 1. Introduction

This document outlines the evaluation of the FuelNet Manager in relation to CE marking. The document presents the compliance to the respective standard that are required to fulfill requirements for CE.

#### 2. Standardizations

The Fuelnet Manager is intended for installation on service stations and connect and control dispensers. The FuelNet Manager is also used to interface other forecourt devices like tank gauge systems, payment terminals and price signs and report data, incl. transaction details to a central head office system called TapNet.

To CE mark a product like the FuelNet Manager, the product needs to live up to the following standards

- Low Voltage Directive (LVD) 2006/95/EG
- Directive of Electromagnetic Compatibility (EMC) 2004/108/EG
  - o EN61000-6-3: 2007 (Emission)
  - EN61000-6-2: 2005 (Immunity)

The following chapters describes how FuelNet Manager lives up to these requirements.
